He is General Secretary of the Administration Board of the European Community Studies Association (ECSA- Greece). He is also Founding Member of the International Association of the Town Planning and the International Law Association (Hellenic Division). He is member of the Hellenic Society of International Law and International Relations.

He founded in 2013 the European Summer School on "European Governance: A new governmental art for Europe" (Lesbos Island).

In 2008, he founded and directed for 3 years the International Master Study Programme on "European Integration and European Societies".
