#### INTRODUCTION

The lesson "EUROPEAN INSTITUTIONS" provides in-depth knowledge of the European Union institutions, EU decision-making process, European governance and the concepts of European identity and European citizenship, as well as the protection of human rights (European citizens) in the framework of the EU primary law (Charter of Fundamental Rights). This knowledge is acquired for the first time since lyceum studies in European Community /Union issues have not been approached accordingly. Through the scientific aids, proposed to the students, we

believe that an in-depth approach to these issues is achieved, as these the most valuable insights on this subject in the context of the Greek and foreign literature.

As a result, they will be able to interpret all the relevant phenomena in the EU reality and by completing their undergraduate studies they will be able to develop a critical approach to all ethical, scientific and social issues related to European construction and integration.

Finally, these abilities allow them to operate with considerable autonomy in their further studies (at postgraduate and doctoral level) as long as they concern the study of the EU and the wider institutional, political and social development of the European space.

Skills and competences to be acquired by students: competences of the institutions, separation of powers within the EU, appeals to the EU Court of Justice, citizens' complaints about breach of primary and secondary EU law, European governance (factors and institutions, influence over the EU decision-making system).

#### **DESCRIPTION OF UNITS:**

i. HISTORY OF IDEA OF EUROPEAN CONSTRUCTION: In this course students will have the opportunity to study thoroughly the way in which the Idea of Europe and European Unification is reflected in the mirror of each historical era. It also focuses on the roots, the development and the impacts of the European Unification Idea as a reality and as a construction. Students will also study the process of Europe's development from an initial cultural idea to a conscious political identity and geopolitical reality.

The unit "History of European Unification idea"" consists of part A' and part B':

-Part A' includes: In the first Unit, is attempted a systematic presentation and a "theoretical assessment" of the initial European Idea as a collective gathering (eg, Humanitarian values, Liberal Democracy, Christianity) in the "Longue durée" of European history. There are also examined the turning point and the ways in which

the notion "Europe" gained its political meaning.

- Part B': In the second Unit, the coherent "European Unification Idea" is approached as a normative starting point of the new Europe after the two great wars of the 20th century . Finally, is examined the most difficult but also most essential phase: the steps towards the construction of the European Communities and the European Union.

Specifically, the course will cover the following:

- Introduction to the History of the European Idea. Political societies and institutions in Europe. Antiquity & Middle Ages
- Modern times (16th -18th century): -Plans for Europe. The secularization of European identity. The European Idea and the Enlightenment. The European Idea in the French Revolution and the Napoleonic Period. European Idea National Idea: The "Romantic Rediscovery of Europe" 1815-1914: 1st part, (from the Vienna Congress and the National R evolutions to the Bourgeois Revolutions)
- The "romantic rediscovery of Europe" 1815-1914: 2nd part, (The unification of the Italian and German states: The Significance for the development of the European Idea and the impact on the evolution of Europe The impact on the European Idea of the transformations in economy)
- World War I and the European Idea. The new initiatives for unification after World War I. The developments in the context of the League of Nations. The Pan-Europa plan. The diplomatic actions. The detailed and sophisticated "Aristide Briand plan".
- From World War II to the Robert Schuman Declaration (1950) and the founding of the European Communities (1958) to the Treaty of the European Union. Theoretical aspects and significations of the Idea in the European space.
- The European Unification Idea in Modern Greek History: The Multiple Meanings The Multiple Identities. -The American "perception" of the European Idea. -The European Idea in the Mirror of the "East".

#### ii. EUROPEAN CONSTRUCTION PROCESS - THEORIES OF EU INTEGRATION:

The objective of this unit is to provide students with the necessary theoretical tools which will enable them understand and interpret the political processes that led and lead the way in European integration. This section presents the basic theories of European integration (Intergovernmentalism, Federalism, Functionalism, Neofunctionalism) and policies, their historical, social, political, and cultural context. In parallel, it examines the evolutionary process of European integration, and the stages in its implementation (Enlargements, Treaties and their political and social context, implementation). Special emphasis will be laid on the Lisbon Treaty Lecturer: Kleio I. Hatzidaniil (PhD candidate)

#### iii. LAW OF THE EUROPEAN UNION:

The objective of the unit is to teach the student the significance of E.U law in shaping the political and social realities of both the E.U Member States and their citizens. The unit aims also, to make the students well acquainted with the basic characteristics of the European legal order. In this context, the section focuses on 1. Elements of Philosophy and Sociology of the Law of the European Union.

2.Fundamental characteristics (E.U as a legal order and as a Union of Law, the subjects of the Union legal order, the autonomy of the Union legal order, the competences and the principles of the functioning of the E.U) 3.Sources (unwritten, written and their hierarchy - primary secondary law) 4.Legislative Bodies (Commission, Council of the European Union, European Parliament) 5.Historical development of the Treaties, 6.Judicial protection mechanisms and the E.U Judicial System – The ECHR within the context of the Council of Europe 7.Relations between EU Law and national law.

#### iv. EUROPEAN UNION GOVERNANCE:

In this course students will have the opportunity to learn how the EU works through its institutions, its governance model and policies. This course combines a mixture of theoretical and interactive learning as students will have the opportunity to get to know the European institutional system and through the study of both institutions and processes, they will have the opportunity to critically analyse them and study possible future developments. The main target is for students to understand the ways European Governance is articulated.

As a course, it combines a mixture of theoretical and interactive learning as students will have the opportunity to get to know the European institutional system and through the study of both institutions and procedures, to proceed to their critical analysis and the study of possible future developments.)

The aim of the course is to understand the forms of governance of the European Union and to analyse the political decision-making processes at the European level and to critically evaluate the transformation of European governance over time in the context of the European legitimation process.

The lectures are structured in the following thematic cycles:

- European governance: a historical review
- Cohesion of the European area
- European governance: The concept of governance: traditional forms of governance in the EU; new forms of European governance
- The informal dimension of European governance Informal bodies Soft law

#### Lobbying

- Multi-level governance: Interaction between supranational, national and sub-national (regional and local) levels.
- Common European policies; Europeanisation of domestic policies
- European governance and democracy: Shaping the European 'demos' Lecturer: Dr Eleftheria Ftaklaki (Post doc researcher))

#### v. EUROPEAN ECONOMIC GOVERNANCE & ECONOMIC AND MONETARY UNION:

In this course students will have the opportunity get in touch with the structure of the European Union economic. This course is a mixture of theoretical and interactive learning as students will have the opportunity to delve into the mechanisms of European Economic Governance, analysing the system of rules, mechanisms and procedures that were gradually established during the creation of the European Union. The legal and institutional dimensions of the development of European economic governance, the way in which the Member States operate under it, the establishment and the need for Economic and Monetary Union established by the Maastricht Treaty and its evolution to date will be examined. The new economic governance, EMU, its institutions, decision-making procedures, etc., are the subject of this course, where students will learn how the model of economic governance in the EU works.

In particular, in this course students will have the opportunity to understand the following:

- European Economic Governance: What it is, how it works, mechanisms of operation
- Crises and the EU.
- Cohesion Policy
- Fiscal Multiannual Programme 2021-2027 Recovery Fund

Lecturer: Dr Eleftheria Ftaklaki (Post doc researcher)

### vi. EUROPEAN UNION IN THE INTERNATIONAL COMMUNITY:

In this course students will have the opportunity to gain knowledge on EU as a Global Actor, the governance of European External Action, the relations of EU with Third countries from a theoretical point of view and, at the same time, take part in practical discussions and mooting on issues regarding the role of EU in the International Community.

The lecture attempts to shed light to the diverse structures of EU Governance in the

field of External Actions. It explores the dynamics of the creation and transformation of the abovementioned structures of European Governance in the era of Lisbon Treaty. The main target is for students to understand the ways EU operates as a Global Actor. At the same time the seminar aims to enhance critical thinking and questioning over the circumstances and the factors that effect on the means, the methods and the procedures followed by the European External Actions.

The course consists of Unit A' and Unit B':

Unit A': -An overview of EU External Action (governance model, institutions, structures, areas of action, sectors, etc.),

- -Multi-level governance and External Action: and the role of Member States; The involvement of local and regional authorities
- How the EU addresses the global challenges of the 21st century at regional and global level (neighborhood policy, development policy, cooperation strategies, etc.)
- -EU operational preparedness CFSP/CSDP
- The externalisation of migration and asylum
- -Development Cooperation; Decentralised Cooperation; Humanitarian Aid; Common Commercial Policy; Economic Cooperation
- -Human rights Conditionality clauses

Unit B': How the EU operates in relation to Third Countries (e.g Africa, or a regional organization (eg African Union, MERCOSUR, etc.) or international organizations (eg WTO, UN, etc.) –

- The EU-Africa-Caribbean-Pacific Partnership (EU -ACP)
- The EU Strategic Relationship with the USA, Russia, Russia, China, Africa, and
- -What are the financial means for the EU External Action, where students have the opportunity to identify and study a specific action- that they will find and develop in the course.
